<p>Mae'r hysbysiad penderfyniad hwn yn cadarnhau bwriad y Comisiynydd yr Heddlu a Throsedd i gomisiynu Agenica Ltd i gynnal adolygiad o'r Asesiad Anghenion Dioddefwyr cyfredol mewn dull graddol.</p> <p>Yn dilyn panel gwerthuso a gynhaliwyd ar 9 Tachwedd 2021, dyfarnwyd £14,475 i Agencia Ltd i gwblhau'r gwaith hwn erbyn Mawrth 2022.</p> <p>Bydd yr adolygiad hwn yn galluogi'r Comisiynydd yr Heddlu a Throsedd i wneud penderfyniadau gwybodus ar ariannu gwasanaethau a gomisiynir yn y dyfodol ac i gefnogi datblygiadau cyfredol ac yn y dyfodol o sut mae dioddefwyr yn cael eu cefnogi ledled Gogledd Cymru. Bydd y gwaith hwn yn cael ei gwblhau mewn 6 cham fel a ganlyn;</p> <p><b>Cam 1</b> - Adolygiad o'r asesiad anghenion cyfredol.</p> <p><b>Cam 2</b> - Proffilio dioddefwyr a nodi patrymau a thueddiadau a nodi meysydd o alw am wasanaethau dioddefwyr.</p> <p><b>Cam 3</b> - Safbwynt dioddefwr i gael dealltwriaeth ddyfnach o brofiad y dioddefwr a sut y gellir cyflawni hyn. Mae gan y CHTH ddiddordeb arbennig yn y ffordd orau o gyflawni hyn.</p> <p><b>Cam 4</b> - Safbwynt Darparwr Gwasanaeth a nodi bylchau yn y ddarpariaeth gwasanaeth ar gyfer dioddefwr. Gallai hyn fod yn gyfleoedd cyd-gomisiynu a chydweithio.</p> <p><b>Cam 5</b> - Safbwynt Partneriaid Strategol. Bydd SCHTh / contractwr yn ymgynghori â rhandaliadau / partion â diddordeb i godi ymwybyddiaeth o'r gweithgareddau uchod, a bydd yn ymgorffori unrhyw adborth, os yw'n briodol, yn yr adolygiad terfynol o'r Asesiad Anghenion Dioddefwyr. Barn y rhandaliadau hyn ar yr hyn sy'n gweithio a pha welliannau y gellir eu gwneud.</p> <p><b>Cam 6</b> - Cyfres o argymhellion i lywio'r ddarpariaeth gwasanaeth yn y dyfodol ynghyd â chynllun gweithredu gyna llinellau amser.</p>	<p>This decision notice confirms the Police and Crime Commissioner's intentions to commission Agenica Ltd to undertake a review of the current Victims Needs Assessment on a phased approach.</p> <p>Following an appraisal panel conducted on the 9<sup>th</sup> November 2021, Agenica Ltd were awarded £14,475 to complete this work by March 2022.</p> <p>This review will enable the Police and Crime Commissioner to make informed decisions on future funding of commissioned services and to support ongoing and future developments of how victims are being supported across north Wales. This work which will be completed in 6 phases as follows;</p> <p><b>Phase 1</b> – A review of the current needs assessment.</p> <p><b>Phase 2</b> – Victim profiling the identification of patterns and trends and identifying areas of demands for victim's services.</p> <p><b>Phase 3</b> – Victim perspective to gain a deeper understanding of the victim's experience and how this can be achieved. The PCC is particularly interested on how this can be best achieved.</p> <p><b>Phase 4</b> – Service Provider Perspective identifying gaps in service provision for victim's. This could be co-commissioning and collaboration opportunities.</p> <p><b>Phase 5</b> – Strategic Partners Perspective. The OPCC/contractor will consult with stakeholders / interested parties to raise awareness of the above activities, and will incorporate any feedback, if appropriate, into the finalised review of the VNA. The views of these stakeholders on what works and what improvements could be made.</p> <p><b>Phase 6</b> – A set of recommendations to inform future service provision together with an action planwith timelines.</p>

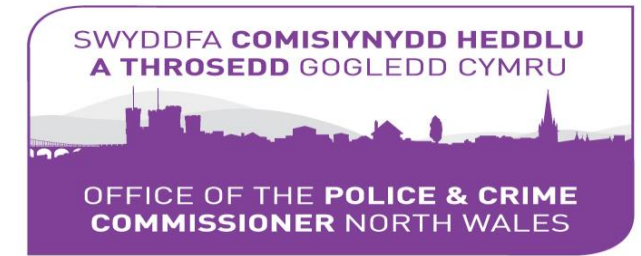

This review will also enable the Police and Crime Commissioner to make informed decisions on future funding of commissioned services and to support ongoing and future developments of how victims are being supported across north Wales.</p> <p>Financial:- £15,000 has been allocated from the Police and Crime Commissioners, Crime and Disorder fund to support this work.</p> <p>Legal:- Anti-Social Behaviour, Crime and Policing Act 2014 enables the Commissioner to commission local services that will help victims, or witnesses of or other persons affected by, criminal offences and anti-social behaviour.</p>

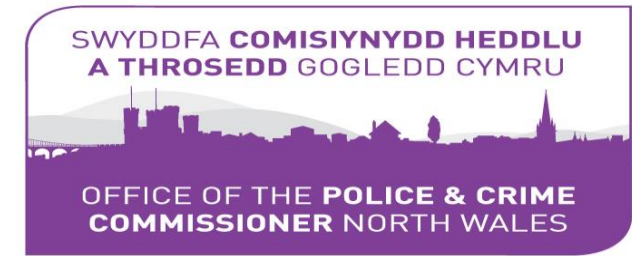
