

Ond nid oedd yn bosibl bryd hynny i brynu ond y tir oedd ei angen. Felly, prynwyd y safle i gyd, gyda'r bwriad o werthu'r gweddill unwaith y cwbllhawyd y gwaith.</p> <p>Mae cynnig wedi'i dderbyn am y swm o £1,300,001, sydd wedi'i dderbyn.</p> <p>Ceir gwybodaeth ychwanegol o fewn yr achos busnes.</p>	Executive Summary: <p>A piece of land comprising approximately 18 acres was purchased at Llay, in order to build a divisional headquarters and custody facility, to replace Bod Hyfryd Tower, Wrexham. The land purchased was significantly larger than that required, but it was not possible at that time to buy only the land needed. Therefore, the whole site was purchased, with the intention to sell the surplus once works were complete.</p> <p>An offer has been received for the sum of £1,300,001, which has been accepted.</p> <p>Additional information is included within the business case.</p>
