Mae rhan CHTh Gogledd Cymru o'r gost yn gyfraniad unwaith yn unig o £26,850.48.</p>	<p>The following was agreed at the Policing and Partnership Board on 18 March 2021:</p> <ul style="list-style-type: none"> <li>• To <b>AGREE</b> the proposal to develop, adopt a National Strategy that is jointly owned and contains a shared vision and blueprint for delivery within the timescales set out in the VAWDASV Act.</li> <li>• To <b>AGREE</b> to formalise a partnership between Welsh Government, HMPPS, Welsh Police Forces, Police and Crime Commissioners that creates an integrated team to oversee and manage a shared project, and agree in principle to allocate resources to implement commitment outlined in Phase 1.</li> <li>• To <b>AGREE</b> the proposed high level timeline included in the paper as a guide for delivery.</li> </ul> <p>Contributions are required from all partners. North Wales PCC's share of the cost is a one-off contribution of £26,850.48.</p>

<p>CHTh Gogledd Cymru a Heddlu Gogledd Cymru i gyfrannu tuag at y prosiect hwn. Darperir adnoddau ychwanegol gan gyrff plismona yng Nghymru, HMPPS a Llywodraeth Cymru. Disgwylir i'r gwaith gael ei gwblhau o fewn un flwyddyn.</p> <p>Mae gan y CHTh y pŵer i ddarparu cyllid sy'n cefnogi plismona a/neu yr amcanion yn ei Gynllun Heddlu a Throsedd.</p> <p>Tra bod menywod a merched yn fwy tebygol o ddioddef cam-drin domestig a/neu drais rhywiol, gall y dysgu o waith VAWDASV gael ei ddefnyddio gyda dioddefwyr a throseddswyr y mathau hyn o gam-drin.</p>	<p>Both North Wales PCC and North Wales Police Force are to contribute towards this project. Additional resources will also be provided by the other policing bodies in Wales, HMPPS and Welsh Government. The work is expected to be completed within one year.</p> <p>The PCC has the power to provide funding which supports policing and/or the objectives in his Police and Crime Plan.</p> <p>While women and girls are more likely to suffer domestic abuse and/or sexual violence, the learning from VAWDASV work can be applied to all victims and perpetrators of these types of abuse.</p>
