

Crynodeb Gweithredol: Mae'r Strategaeth Gyfalaf a'r Strategaeth Rheoli'r Trysorlys yn dilyn fformat, yn unol â <i>Treasury management in the Public Sector: Code of Practice and Cross-Sectoral Guidance Note (CIPFA 2017)</i> . Mae gofyn i'r Comisiynydd cyn dechrau'r flwyddyn ariannol: <ul style="list-style-type: none">• Cytuno'n ffurfiol ar y Rhaglen Gyfalaf fel rhan o'r Strategaeth Gyfalaf;• Darparu fframwaith y strategaeth i Reoli'r Trysorlys;• Cytuno ar Reoli'r Trysorlys a Dangosydion Darbodus;• Cytuno ar y dull a fabwysiedir ar gyfer ad-dalu dyled (Darpariaeth Refeniu Sylfaenol). Trafodwyd y Strategaeth Gyfalaf ddrafft a'r Strategaeth Rheoli'r Trysorlys ddrafft gan y Cydbwylgor Archwilio ar 30 Mawrth 2021. Mae'r strategaethau hyn yn eu hanfod yn debyg i'r rhai maent yn eu disodli. Gwnaeth y Cydbwylgor Archwilio seilio eu hargymhelliaid ar sail y crynodeb gweithredol gwnaethant ei dderbyn, oherwydd mae'r strategaethau'n ddogfennau cymhleth a thechnegol	Executive Summary: The Capital Strategy and Treasury Management Strategy follow a format, in line with the <i>Treasury management in the Public Sector: Code of Practice and Cross-Sectoral Guidance Note (CIPFA 2017)</i> . The Commissioner is required before the beginning of the financial year to: <ul style="list-style-type: none">• Formally agree the Capital Programme as part of the Capital Strategy;• Provide the strategy framework for Treasury Management;• Agree the Treasury management and Prudential Indicators;• Agree the method adopted for the repayment of debt (Minimum Revenue Provision). The draft Capital Strategy and draft Treasury Management Strategy were discussed by the Joint Audit Committee on 30 March 2021. These strategies are fundamentally similar to the ones they replace. The Joint Audit Committee based their recommendation on the basis of the executive summary received, because the strategies are complex, technical documents.	
Goblygiadau: Amcan Strategaeth Rheoli'r Trysorlys yw i'r Comisiynydd Heddlu a Throedd fuddsoddi a benthyg i roi sicrwydd, hylifedd ac arenillion ariannol yn y drefn honno. Mae'n ofyniad i gymeradwyo'r strategaeth cyn dechrau'r flwyddyn ariannol. Mae adnoddau ariannol digonol yn ofyniad allweddol i gyflawni'r Gofyniad Plismona Strategol a'r amcanion yn y Cynllun Heddlu a Throedd. Mae'r rhaglen gyfalaf yn rhan hanfodol o sicrhau bod Heddlu Gogledd Cymru yn addas i gyflawni ei gyfrifoldebau.	Implications: The objective of the Treasury Management Strategy is for the Police and Crime Commissioner to invest and borrow to provide financial security, liquidity and yield in that order. It is a requirement to approve the strategy before the beginning of the financial year. Adequate financial resources are a key requirement to the delivery of the Strategic Policing Requirement and the objectives in the Police and Crime Plan. The capital programme is an integral part of ensuring North Wales Police is suitably equipped to deliver its responsibilities.
