

<b>Crynodeb Gweithredol:</b>  Cyflwynwyd adroddiad i'r Panel Heddlu a Throedd ar 2 Chwefror 2021 yn argymhell y dylid codi'r praecept i £89,687,902 sef cynnydd o 5.53% yn y praecept, cyfwerth â chynnydd o 5.14% mewn Treth Cyngor. Roedd yr adroddiad hefyd yn cynnwys cynigion ar gyfer y blynnyddoedd 2021/22 tan 2025/26 a chyflwynwyd y cynllun ariannol tymor canolig er mwyn cefnogi'r adroddiad.  Cafodd y cynnydd arfaethedig i'r preasept ei gadarnhau gan y Panel Heddlu a Throedd.  Derbynwyd setliad terfynol y grant ar 4 Chwefror 2021.	<b>Executive Summary:</b>  A report was taken to Police and Crime Panel on 2 February 2021 proposing that the precept be increased to £89,687,902, an increase of 5.53% in precept, equivalent to 5.14% increase in council tax.  The report also included outline proposals for the years 2021/22 to 2025/26, and the medium term financial plan was presented to support the report.  The proposed increase in precept was ratified by the Police and Crime Panel.  The final grant settlement was received on 22 January 2020.
