

<p>Mewn ymateb i COVID 19 mae arian wedi cael ei neilltuo i gefnogi prosiect ymateb cyflym Home Start. Nod y prosiect yw cefnogi teuluoedd sydd wedi cael eu heffeithio gan gam-drin domestig drwy gyflogi gweithiwr cefnogol i deuluoedd er mwyn lleihau effaith trawma ar y teulu.</p> <p>Bydd Home Start yn gweithio gyda 7 teulu ar y tro yn eu cefnogi i ateb anghenion eu plant drwy ddulliau rhithiol neu wyneb yn wyneb. Bydd y prosiect yn ceisio lleihau ynysu cymdeithasol, gwella hunan-barch a gwynnchw teuluol a gwella hyder i fod yn rhieni.</p>	<p>In response to COVID 19 a contribution of funding has been awarded to support the Home Start rapid response project. The project aims to support families who have been affected by domestic Abuse via a paid family support worker in order to reduce the impact of the trauma on the family.</p> <p>Home Start will work with 7 families at one time and support them to address the children’s needs via virtual means or face to face. The project will aim to reduce social isolation, increase self-esteem and family resilience and improve parenting confidence.</p>

This work will be monitored through highlight reports, data submissions and monitoring visits conducted by the Office of the Police and Crime Commissioner.</p>


