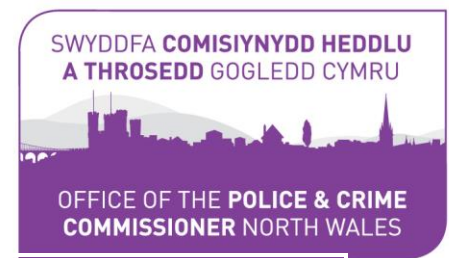

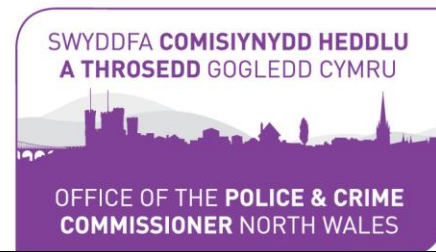



Crynodeb Gweithredol:	Executive Summary:
<p>Mae'r Tîm Troseddau Cefn Gwlad wedi bod yn gweithio ar brosiect o'r enw Future Farms Cymru. Nod y prosiect yw annog y defnydd o dechnoleg troseddau cefn gwlad ar ffermydd (yn enwedig synwryddion sy'n canfod troseddau cefn gwlad mewn amser real drwy system hysbysu/Ap.)</p> <p>Mae'r prosiect yn cynnwys nifer o ffrydiau gwaith ond mae un ffrwd gwaith yn gofyn am arian ychwanegol. Mae'r ffrwd waith yn cynnwys cynnal digwyddiadau Hacathon, ble mae cystadleuwyr yn derbyn her i greu dyfeisiadau prototeip yn gyfnewid am i) gwobr ariannol o £1,000; ii) mynediad am ddim i labordai Prifysgol Bangor i'w helpu i ddylunio ac adeiladu synwryddion iii) help oddi wrth M-Sparc i droi eu dyfeisiadau yn fusnesau a iv) y cyfle i ddangos eu cynnyrch ar ein ffermydd demo a chael eu gweld gan gwsmeriaid/ffermydd.</p> <p>Cyfanswm yr arian sydd angen ar gyfer y wobr ariannol yw £3,000. Casglwyd £2,500 oddi wrth sefydliadau eraill. Dyma gais am £500 oddi wrth y Comisiynydd Heddlu a Throsedd.</p>	<p>The Rural Crime Team has been working on a new project called Future Farms Cymru. The aim of the project is to encourage the use of rural crime technology on farms (particularly sensors that detect rural crimes in real time then alert the farmer via an app/notification).</p> <p>The project includes several workstreams but one workstream requires additional funding. This workstream involves holding a Hackathon events, where contestants are challenged to create prototype devices in exchange for i) prize money of £1,000; ii) free access to Bangor University labs to help them design and build their sensors, iii) help from M-Sparc to turn their prototypes into products and their ideas into businesses, and iv) the opportunity to showcase their products on our demo farms and thereby access customers/farmers.</p> <p>The total amount of funding required for the cash prizes is £3,000. £2,500 has been sourced from other organisations. This is a request of £500 funding from the Police and Crime Commissioner.</p>
