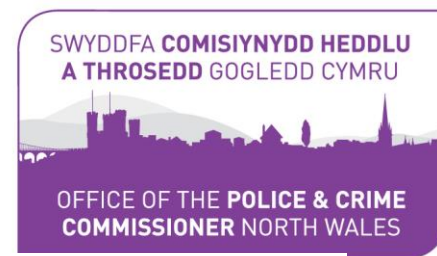

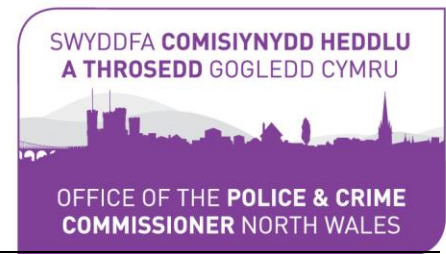

Mae hefyd y Corff Adolygu Perthnasol i ystyried cwynion sydd wedi cael eu trin gan Adran Safonau Proffesiynol yr Heddlu.</p> <p>Mae'r rhain yn ddyletswyddau statudol a ellir eu dirprwyo i'r Prif Weithredwr/Swyddog Monitro i'w hystyried ar ran y CHTh.</p> <p>Er mwyn sicrhau gwytnwch wrth ymdrin â'r achosion hyn, gofynnir i'r CHTh ddirprwyo'r swyddogaeth hon i'r Prif Weithredwr/Swyddog Monitro.</p>	<p>The Police and Crime Commissioner (PCC) is the Appropriate Authority to consider complaints about the Chief Constable and is also the Relevant Review Body to consider complaints which have been dealt with by the Force's Professional Standards Department.</p> <p>These are statutory duties that may be delegated to the Chief Executive/Monitoring Officer to consider on behalf of the PCC.</p> <p>To ensure resilience in dealing with these cases, the PCC is asked to delegate this function to the Chief Executive/Monitoring Officer.</p>
