| Gofynnwyd i holl Gomisiynwyr Heddlu a Throedd gyfrannu at Rwydwaith Cenedlaethol Atal Masnachu Pobl a Chaethwasiaeth Fodern, i roi cymorth ariannol i'r Llinell Gymorth Caethwasiaeth Fodern. Gofynnwyd i bob ardal heddlu gyfrannu £10,000. O ystyried bod Heddlu Gogledd Cymru yn heddlu llai o faint, sy'n cynrychioli ychydig dros 1% o boblogaeth y DU, mae'r Comisiynydd Heddlu a Throedd wedi penderfynu cyfrannu £2,500, i'w ariannu o'r Gronfa Diogelwch Cymunedol. Mae'r taliad hwn wedi'i gymeradwyo o'r flwyddyn ariannol 2020/21 yn unig. | All Police and Crime Commissioners have been asked to contribute to the National Anti-Trafficking and Modern Slavery Network, to provide financial support for the Modern Slavery Helpline. Each police force area has been asked to contribute £10,000. Given that North Wales is a small force, representing a little over 1% of the UK population, the Police and Crime Commissioner has decided to contribute £2,500, to be funded by the Community Safety Fund. This payment has been approved from the financial year 2020/21 only |
