

Rwy'n falch o adrodd bod fy nghynigion praesept treth cyngor wedi'u cymeradwyo'n unfrydol yn y Panel Heddlu a Throsedd diweddaraf, ac mae un ohonynt yn fenter i arfogi ap cyfathrebu symudol soffistigedig i bob swyddog rheng flaen, sy'n rhan o fy strategaeth cyfathrebu digidol pedair blynedd. Bydd arian y trethdalwr yn sicrhau y bydd fy strategaeth yn cwtdogi ar yr amser a dreulir yn cwblhau gwaith papur ac yn ei dro, yn cadw cymunedau a'u timau plismona lleol mewn cysylltiad agos, gan olygu y bydd swyddogion yn gallu treulio mwy o amser ar y strydoedd yn helpu'r cyhoedd.

Bydd y cynnydd hwn hefyd yn helpu i dalu am Hwb Atal Troseddau Canolog newydd i gydlynu gwaith timau rhanbarthol yn ardaloedd Dwyrain, Canol a Gorllewin Heddlu Gogledd Cymru. Mae'r Hwb Atal yn cyd-fynd â'r blaenoriaethau yn fy Nghynllun Heddlu a Throsedd ynghyd â chynlluniau fel Checkpoint Cymru, sy'n ceisio rhyng-gipio pobl cyn iddynt gael eu dal yn y system cyfiawnder troseddol, mynd i'r afael ag achosion sylfaenol ymddygiad troseddol ac atal y patrymau aildrosedd.

Ym mis Chwefror 2020, daeth Heddlu Gogledd Cymru yn Heddlu arweiniol yng Nghymru a Lloegr drwy gynnal y Rhwydwaith Ymchwilio Gwrthdrawiadau Fforensig (FCIN). Mae Ymchwilio Gwrthdrawiadau Fforensig yn faes plismona hynod arbenigol, sy'n cynnwys nifer fach o staff gwyddonol a thechnegol sy'n darparu gwasanaeth cyhoeddus sylweddol i ymchwilio i farwolaeth ac anafiadau difrifol, sy'n aml yn newid bywyd, ar ein ffyrdd. Mae'r daith yn un bwysig ac angenrheidiol, sydd wedi arwain at gytundeb cydweithredu unigryw rhwng pob un o'r 43 Prif Gwnstabl a Chomisiynydd Heddlu a Throsedd yng Nghymru a Lloegr. Dyma un o'r gwasanaethau cyntaf i fabwysiadu dull sydd wedi'i achredu'n annibynnol yn genedlaethol, gan ddangos y gall Gogledd Cymru arwain y ffordd o ran arloesi o'r math hwn.

Er bod 2020 wedi bod yn flwyddyn anodd a heriol i lawer, rwyf wedi sicrhau bod ymateb i argyfwng Coronavirus a chyflawni fy nghyfrifoldebau statudol wedi bod wrth wraidd fy mlaenoriaethau. Ym mis Mai, cyhoeddais Gynllun Ymateb Coronafirws, a amlinellodd fy nod i gadw Gogledd Cymru yn ddiogel yng nghanol y pandemig. Ers hynny, mae fy swyddfa a minnau wedi gweithio'n galed i sicrhau bod y gwasanaethau a gomisiynir yn parhau i weithredu a chefnogi pobl agored i niwed ac, ar ran ein cymunedau, bod yr heddlu'n ymateb mewn ffyrdd sy'n angenrheidiol, yn ddigonol, yn gymesur ac yn foesebol. Roedd cyllid gan y llywodraeth ar gael i gwmpasu'r ymateb plismona i COVID-19, gan geisio lleihau'r effaith uniongyrchol ar dalwyr trethi cyngor Gogledd Cymru.

Comisiynydd Heddlu a Throsedd Gogledd Cymru

I'm pleased to report that my council tax precept proposals were unanimously approved at the most recent Police & Crime Panel, one of which being an initiative to equip every frontline police officer with a sophisticated mobile communications app, which forms part of my four-year digital communications strategy. The taxpayer's money will ensure that my strategy will cut down on time spent completing paperwork and in turn, will keep communities and their local policing teams in close contact, meaning officers will be able to spend more time on the streets helping the public.

This increase will also help pay for a new Central Crime Prevention Hub to co-ordinate the work of regional teams in North Wales Police's East, Central and West areas. The Prevention Hub ties in with the priorities in my Police & Crime Plan along with schemes like Checkpoint Cymru, which aims to intercept people before they get caught up in the criminal justice system, addressing the root causes of criminal behaviour and stop the re-offending patterns.

In February 2020, North Wales Police became the host Force in England and Wales leading the Forensic Collision Investigation Network (FCIN). Forensic Collision Investigation is a highly specialist area of policing, involving a small number of scientific and technical staff who provide a significant public service to the investigation of death and serious, often life changing, injuries on our roads. The journey is an important and necessary one, which has led to a unique collaboration agreement between all 43 Chief Constables and Police & Crime Commissioners in England and Wales. This is one of the first services to adopt an independently accredited approach nationally, showing North Wales can lead the way in innovation of this kind.

Whilst 2020 has been a difficult and challenging year for many, I have ensured that responding to the Coronavirus emergency and fulfilling my statutory responsibilities has been at the core of my priorities. In May, I published the Coronavirus Response Plan, which outlined my actions and aims to keep North Wales safe in the midst of the pandemic. Since, my office and I have worked hard to ensure that PCC commissioned services continue to operate and support vulnerable people and, on behalf of our communities, that the police respond in ways that are necessary, sufficient, proportionate and ethical. Government funding was made available to PCCs to cover the policing response to COVID-19, seeking to minimise the direct impact on North Wales' council tax payers.



Cymharu lefel y Gyllideb Refeniw â chanllawiau Llywodraeth Cymru

Gan ddefnyddio fformiwla a luniwyd ar gyfer pob Heddlu yng Nghymru a Lloegr, mae Llywodraeth Cymru a'r Swyddfa Gartref wedi cyflwyno "safon gwariant" a elwir yn Aseiad Gwariant Safonol (AGS) a Grant yr Heddlu o £137.688m ar gyfer 2021-2022. Dyma yw aseiad y Llywodraeth o'r hyn y bydd angen i'r Comisiynydd ei wario er mwyn darparu un lefel o wasanaeth â chomisiynydd eraill yng Nghymru os ydynt hwythau hefyd yn gwario yn unol â chyfanswm eu AGS a'u Grant Heddlu eu hunain.

Mae gan y Comisiynydd hawl i wario mwy na chyfanswm yr AGS a'r Grant Heddlu, gyda'r gwahaniaeth yn cael ei ariannu gan y Treth Cyngor neu o'r Cronfeydd Wrth Gefn. Mae'r Comisiynydd wedi penderfynu ar ofyniad Cyllideb o £173.365m.

How much of your council tax is spent on policing?

There are nine council tax bands in North Wales, based on the capital value of the property in 2003.

\*Band D is used for National comparisons of tax levels. From a Band D Council Tax bill, only £305.55 is allocated to funding the Police service of North Wales, as agreed by the Police and Crime Commissioner for North Wales


Therefore, depending on your property band, the amount from your Council tax bill which funds the Police Service of North Wales is as follows:

Comparison of the level of the Revenue Budget with the Welsh Government's guidance

Using a formula developed for all Police Forces in England and Wales, the Welsh Government (WG) and the Home Office have issued a "spending norm" known as the Standard Spending Assessment (SSA) plus Police Grant of £137.688m for 2021-2022. This is the Government's assessment of the Commissioner's need to spend in order to provide the same level of service as other commissioners in Wales if they also spend at the level of their own SSA plus Police Grant.

The Commissioner is allowed to spend in excess of its SSA/Police grant total, with the excess being funded from the Council Tax or Reserves. The Commissioner has set a Budget requirement of £173.365m.
